The Directorate of Corporate Affairs is a unit within the Vice-Chancellor's office. This office was established in 2016. The main arms of the office are public relations, international student affairs, and corporate relations.

# **Functions of the Directorate of Corporate Affairs**

- o Provide leadership and support to the University's corporate functions
- o Provide leadership in editorial functions of the University
- o Promote the image (reputation) of the University
- Promote and maintain mutually beneficial relationships with the Government
   (National and County governments) and corporate Organizations

- Promote change and innovation through timely response to the needs of university community
- o Facilitate protocol at the Chancellor's and the Vice –Chancellor's office
- o Advise on public policy and administrative matters.
- Manage the relationship between the University and media houses
- o Monitor and analyze media and report
- Monitor the implementation of the communication strategy, branding policy, social media policy and marketing policy

#### **Public Relations Office**

The Public Relations Office is responsible for handling all aspects of planned publicity campaigns and PR activities.

- o Organizing promotional events such as open days, exhibitions, tours and visits

- o Analyzing media coverage
- Monitoring the implemented communication strategy
- o Commissioning or undertaking relevant market research
- Liaising with clients, managerial and journalistic staff about budgets, timescales and objectives
- o Providing in-house media support
- Designing, writing and/or producing presentations, speeches, press releases, articles, leaflets, 'in-house' journals, reports, publicity brochures, and posters information for websites and promotional videos and documentaries
- Implementing the university's social media strategy
- Monitoring and managing customer feedback through E-mail, website and social media platforms

# **Corporate and Community Outreach activities: Webinars**

As part of outreach, the Corporate affairs office was involved in organizing webinars and seminars around the UoN at 50 celebrations. The following webinars were successfully live streamed:

- A Crisis of Climate or Choice? Risks and response to improving water security for the poor. Hosted by The Institute for Climate Change and Adaptation, College of Biological and Physical Sciences, the lecture focused on the climate crisis from the perspective of social choices in rural Africa and Asia. The discussion was situated in terms of the risks and responses people face in their lives and livelihoods at home, work and school. Drawing upon inter-disciplinary research with practitioners in multiple countries, the forum reviewed multi-decadal data, providing insights into the structural inequalities which constrain the daily chores of rural people. It was evident that a legacy of well-meaning but poorly executed policy and investments demand new thinking in allocating water security risks and responsibilities between communities, markets and states. The forum further discussed emerging responses including the launch of performance-based funding for rural water services for over one million people in the Central African Republic, Burkina Faso, Kenya and Uganda.
